Owner agrees to pay all costs and charges for special services requested, and all veterinary costs for the pet during the time pet is in care of the kennel, when pet is picked up. 3. Owner agrees that the pet shall not leave the kennel until all charges are paid to the kennel by owner. 4. By signing the contract and leaving his/her pet with the kennel, owner certifies to the accuracy of all information given about pet on this contact and makes the kennel guardian while boarding. 5. If pet becomes ill or if the state of pets health otherwise requires professional attention, then kennel, in its discretion, may use the services of the veterinarian, administer medicine or give required attention to the pet and the expenses there of shall be paid by the owner. 6. This contract contains the entire agreement between parties. All terms and conditions of this contract shall be binding on the heirs, administrators, personal representatives and assigns of the owner of the kennel. 7. Any controversy or claim arising out of or relating to this contract, or breach thereof, or as a result of any claim or controversy involving alleged negligence by any party to this contract shall be settled by a hearing with District Justice David Brian, 399 Camp Meeting Road Landisville, PA 17538.
